Update Plunge Pool

Met with Engineer and reviewed the agreed-on areas determined in the previous weeks of inspection.

Design L27 in phases, 1st phase is a 2 gang catch basin at the intersection of Manion and Deepwood Drive. Future phases would install possible asphalt and catch basins along the side of Manion to catch runoff before it reaches Deepwood Drive.

Performed review in coordination with Lebanon roads lead, Allison Stec

The engineer asked for various prints to help in the proposal development which Les provided shortly after the meeting.

It was agreed to design L25 Next for it needed less work. This will most likely be designed later this year. The Engineer took notes from our review of the area.

Action: Frank to ask Maureen for results of plunge pool cleanings

Review of sample results

One sample data returned, expect recent sample in a few days. Results for the 2nd storm water samples were obtained June 6, 2019 for H11,15,16,17, and L12,20,25,27,32,33.

It was discussed to possibly wait 3 samples to see results from additional testing before we discuss any changes in the sampling. AER will be asked for their input

Longitude and latitude data of inlets were sent to AER for their use. Les will also add to the Storm Water document he is preparing.

Emergency action plan to be followed which include, periodic inspections, education, review of past efforts, future efforts

Boat Slips

One resident address asked about slips for larger boats (pontoon)

Study to determine additional slips for larger boats

17 slips, 4 are for 20-foot pontoons

Moring has been an issue in the past due to people noting the boat is in front of their property but not their boat. This is typically because of the shoreline curvature.

Separate committee, needs to have the right people to fully address the pros and cons.

Invasive Weeds

Northeast cove weed issue, Phragmite

The area of invasive weeds was inspected and the only areas that the species is advancing is along the immediate shoreline. No advancement in approximately 95% of the perimeter.

The shoreline at 6 Deepwood drive and at 20 Deepwood drive where it has moved about 10 to 15 feet since September 2018.

Action - Have AER review site, Jeff to talk AER for visit and to note that is was an area that had dredging performed. AER to be asked to confirm the spread across the street at #7 Deepwood.
