

Amston Lake District Volunteer Release and Waiver of Liability

This Release and Waiver of Liability (the "Release") executed by _____ ("Volunteer") for calendar year _____ releases the Amston Lake District ("ALD"), a special district organized and existing under the laws of the State of Connecticut, and each of its directors, officers, employees, and agents. The Volunteer desires to provide volunteer services for ALD and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of Volunteer's relationship with ALD is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that ALD will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to ALD. ALD's provision of time, materials, instruction, training and/or access related to the services provided by the volunteer, which would otherwise not be provided, constitute the consideration for the agreements herein.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless ALD and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to ALD. I understand and acknowledge that this Release discharges ALD from any liability or claim that I may have against ALD with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to ALD or occurring while I am providing volunteer services.
2. Insurance: Further, I understand that ALD does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of ALD beyond what may be offered freely by ALD in the event of injury or medical expenses incurred by me.
3. Medical Treatment: I hereby Release and forever discharge ALD from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with ALD.
4. Assumption of Risk: I understand that the services I provide to ALD may include activities that may be hazardous to me including, but not limited to standing, walking or working in or near Amston Lake, its dams, beaches, other lake access points, boat racks and docks, and boating and property maintenance activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and Release ALD from all liability.
5. Photographic Release: I grant and convey to ALD all rights, title and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by ALD in connection with my providing volunteer services to ALD.
6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Connecticut and that this Release shall be governed by and interpreted in accordance with the laws of the State of Connecticut. I agree that in the event that any clause of provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
