- Security F. Hoisl Reviewed neighborhood block watch information from the August 9th Security Committee meeting. Refer to Security Committee Minutes dated August 9, 2012.
- 2. Dam D. Moorcroft Email notification to be sent to residents notifying them that on August 27th the ALD Board will start the process to lower the water level for the Main Dam Spillway Repair (project to start on October 1st) The goal is to lower the water 20 to 24" below the spillway by October 1st. The water must be lowered in a controlled fashion to avoid any over filling of the Duck Pond. The forth coming email will explain the process in detail to the residents.
- 3. Storm Drains D. O'Brien and R. DeCormier met with BSA on Sunday, August 12th to review the SW Cove engineering drawings for October 15th Dredging Project. After the Old Firehouse project is completed in September, D. O'Brien will continue to work with the Town of Hebron on a new location for the Vortechnic Unit installation. Must have permission in writing from residents near the proposed installation before proceeding with the Town of Hebron to engineering review/plan.
- 4. Lebanon Sewer Project D. Martin Absent. Paul Oliver (Lebanon resident attending the meeting provided the ALD Board with an update. Note: Paul Oliver is a member of the Lebanon WPCA). Project is proceeding well and is ahead of schedule by 60 days. Lebanon WPCA is working closely with all parties involved.
- 5. Drinking Water no report. S. Martin absent.
- Boats & Rafts D. Moorcroft, M. Paul, Carl Wool provided the ALD Board with an update of their recent Committee meeting (refer to their Committee meeting notes). This Committee will issue a series of emails informing the residents to remove their boats from ROWs by November 1st for end of year ROW clean up.

A motion was made by R. DeCormier to spend up to \$300 dollars produce 12 signs to notify the residents of boat remove and ROW clean up (3 Large signs 18" by 24" and 9 smaller signs 15" by 18"). The signs will be placed at the entrances of Amston Lake and at the ROWs. D. Moorcroft second.

- K. Act on Remaining Items of Agenda....Old Business Neal Family Property: Do we want to own this and pay additional taxes on property that may not be useful? Discuss again at next meeting. Reviewed the information from Traci Neal regarding lots on Lebanon side of lake. D. O'Brien to contact Traci for additional information on the lots for possible open space consideration by the ALD Board. After additional information is collected, the ALD Board will determine if this needs to be brought to the residents for their consideration.
- L. New Business..... Discussion and Possible Action

The ALD Board discussed the liability and risk (District insurance/liability implications) of the Lake Day launch of 54 (number may vary) Sky lanterns. Read information below. The ALD Board determined that it is NOT worth the risk of a lawsuit against our assets (cash in Bank, District owned Lands) to allow this practice to continue on Amston Lake District owned property. D. O'Brien to discuss this with ALA Board.

Sky lanterns, also known as **Kongming Lantern** or **Chinese lanterns** are airborne <u>paper lanterns</u> that are best known as a tradition found in some Asian cultures. They are traditionally constructed from oiled <u>rice paper</u> on a <u>bamboo</u> frame, and contain a small <u>candle</u> or fuel cell composed of a waxy <u>flammable</u> material. When lit, the <u>flame</u> heats the air inside the lantern, thus lowering its density causing the lantern to rise into the air. The sky lantern is only airborne for as long as the flame stays alight, after which the lantern sinks back to the ground.

Sky lanterns are also referred to as sky candles.

Lanterns have proved extremely unpopular with farmers in many countries due to the potential for causing crop fires and the chance of death of livestock on consuming the lantern remains upon landing.^[1]

Legal Information from Google

Well, ..., as far as I know there's no specific law prohibiting them. However, in any situation, it is illegal to to put public safety at risk. Sky lanterns are a cool idea, however, they represent a significant public safety risk. If one were to fall to earth and catch fire the property loss could be devastating, many people could be harmed, and even lose their lives. Make no doubt about it the law would come for you and they wouldn't accept a flimsily excuse of "Well, the law doesn't say you can't ...". Believe me that would melt before the blazing glare of any court judge.
