# **Approve August Meeting Minutes**

#### **Beaches and ROWs**

Updates to ongoing or future efforts

- At 9/16/2020 BOD meeting B&R requested to have ALHC attend B&R meetings to support questions, Jeff Arpin requested to attend and accepted
  - Jeff will report on the meetings he attends, next meeting 10/8/2020
- It was noted Jeff Hatch did a great job on Elsmere ROW minimizing erosion with Rip Rap although there are some residence that have complaints.

#### **Erosion Control**

#### Manion Road Catch Basin design modification

- o meeting update with Lebanon town Officials, Jeff Arpin
  - Jeff sent emails to the town of Lebanon to schedule another meeting. Jeff sent the town his meeting notes to be used in the discussions.
  - A continued discussion and agreement on the need for the Lebanon roads committee to get more members and become more involved in erosion control in place of lake health leading. Frank will discuss with the committee chair (Action)

## Plunge Pool Design progress

- o Civil Engineering completed A2 Survey progress for Lollipop, Frank Hoisl
  - The design was completed and noted the current detention basin not on the Districts property, Frank will discuss with the home owner (Action)
  - Frank has the survey map mylar and it has been recorded in the town of Lebanon.
  - Discussion of moving sand out of the lake to other areas noting that no permit is required if performed by hand using no machinery per franks discussion with the town on Lebanon.
- o 6 Deepwood Drive Lebanon plunge pool update
  - Detention basin cleaned 9/29/20 by local contractor

Discussion of working on the detention basin in the front of Dave Bareiss property because he plans to start work soon. Jeff noted we needed to follow our plans and get one design implemented in place of continuing with more designs and not implementing any of them. We currently have 3 designs but no plans on actual implementation. More discussion on this topic possibly needed.

# • Lebanon land conservation interface (2020 Lebanon POCD)

- Obtain public comment copy, Les Parlin
  - Les reviewed the areas of the plan that he thought affected Amston Lake and was pleased with the information that was in the draft. Les noted it included a drainage management plan but was concerned who owned it. The plan also noted that they expect over 100 homes to be converted from seasonal to year around at the lakes in the town which is similar to past growth.
    - In reviewing the 2020 Lebanon POCD, Les found the following pages most relevant to ALHC:
      - o page 13 (Housing at Lakes)
      - o pages 33,34, and 35 (#10)
      - o page 46 (Implementation Table #11)
- o who to coordinate Amston lake comments?
  - Les noted the committee needs to review and provide comments and the BOD will summarize and provide to the town of Lebanon. Final comments should be in by November so they can be sent to the town in time to be reviewed by the public meeting in December. Frank to send email blast requesting comments on the POCD (Action 114).
- Frank mentioned Brandon is acquiring some pricing to pave Amston Lake district roads that are in Lebanon.
  - what are the specifications/specific plans?
  - Frank to draft an e mail blast looking for committee volunteers and explaining the Lebanon POCD vs what Hebron has implemented.

## Barley Straw

- o Inspection results H11, H16
  - H11 most straw not in the tubes, H16 all straw intact. Not sure why one area held up better than the other. Al noted H11 is very windy.
- o Barley Straw Removal H11 on 9/16/2020, H16 on 9/25/2020

#### • Dam

- Maintenance of emergency gate valve completed, greased and closed then reopened.
- Installation of lake level gage TBD
- o Wier Board status, Lake very low due to mother nature,
  - Frank reported the lake level was 8 inches below the overflow on 10/4
  - Discussion of weir board removal: it was agreed to wait because the lake is already very low and only needs another 4 +/- inches before lake freeze. Will look at the 3<sup>rd</sup> week of October but need to consider boats still in the lake and need enough water to get to the boat launch. Many rocks near the launch.


## Housing Starts

- Lebanon Draft of 2020 Plan of Conservation and Development Released
  - Expects 100 house conversions over the next 10 years

#### 2020 Water Test Program

- Safety and identification vest for ALHC performing Volunteer work
  - Frank agree to get prices of vests labeled with Amston lake Volunteer (Action 141)

- Algae discussion, lake wide update
  - See deep water tests below
- Barley Straw update and Impact
  - Not much impact could be measured because no inlet flow where the tubes were installed due to minimal rain this year.
  - H16 did have a reasonable large area of Algae (30 ft X 30 ft)
- AER Plant Survey 7/18/2020 preliminary discussion, AER Report is expected in November 2020
- Deepwater tests performed on 5/7, 5/20, 6/2, 6/17, 7/2, 7/13, 7/29, 8/9, 8/24, 9/6
  - AER reported 9/18 Algae and cyanobacteria cell concentrations are still generally low (3,200 and 2,200 cells/mL respectively). The dominant cyano genus was Microcystis which we need to keep our eye on (see below). But cell concentrations are still well below those that are problematic.

- Al noted on 10/4 that for the last few days he has seen what MIGHT BE cyanobacteria in various areas around the lake. For the most part it seems to be gathered up on the shores, depending on which way the wind is blowing on that day. He was also seeing larger clumps of possibly the same thing actually laying on the lake bottom. To be clear, this is in no way a major bloom! I just get a little concerned when it becomes so visible and noticeable to me. Just wondering if any recent samples have shown an increased level of cyanobacteria lately. Jeff noted it is consistent with the findings from the recent deep-water testing and analysis by AER.
- Stormwater testing performed on 4/9, 5/1, Limited rain fall to collect
- North cove versus other lake areas sediment measurement plans,
  - o Agreed to use volunteers from ALHC in August meeting
  - Team to be determined to develop a plan and perform measurements

# Remaining sewer hookup status (Tracking Spreadsheet updated)

- Lebanon WPCA update, Jeff Arpin
  - o Continue to follow and document connections

## **Lake Health Historical documentation**

- Committee review of Lake history document, Spreadsheet issued 9/17 for review and comment
  - Jeff requested all members review and provide comments. Jeff has tried to keep up to date throughout the year but may have missed an important item that other saw while boating or swimming in the lake. (Action 140)
- ALHC Website update, Jeff Arpin
  - Jeff met with Liz Bowen and agreed to implement one part of the website modification to see how well it works. This was the Analysis and Reports section

#### **Future activities**

Amston Lake Home Owners Guide update, Kathy G

- Kathy not in attendance to report
- o Ordinances review and enforcement, remind us all of our rules
  - Frank will follow up
- Lake residence requesting some rock removal in specific areas for boat safety
  - Jeff noted with some residents getting larger boats he was approached about rock removal to reduce boating damage. The committee did not resolve if this was acceptable. BOD to address (Action 142)

#### Other Items discussed

- Lebanon Roads
  - Need more than a one person Lebanon roads committee, Will help with the Erosion control interface with the Health Committee
  - A cost benefit analysis should be done comparing continued maintenance of gravel roads versus paving
- Property owner adding fabric to the lake to eliminate plant growth. This seems to be the same person as installed sand in previous years and were talked to about lake ordinances. Frank will approach the land owner (Action 143)
