#### 1. Roll Call of members:

#### 2. Approve Previous Months Meeting Minutes

1<sup>st</sup> Al Fichtel, 2<sup>nd</sup> Joyce Clark, Minutes unanimously approved

#### 3. Committee interface

#### Beaches and ROWs

- B&R meeting update
  - Smoking debris on Beaches
    - Kathy Feldman noted the B&R is setting up a small group of people to discuss the beaches during the start of the year to make recommendations via the information provided by Kathy about cigarette filter effects on water
  - Elsmere RoW looks like there is a "Sink Hole" issue at the water's edge but it is believed its due to the low lake level and should be covered once water level returns
- Roads
  - o Lots of sand on the Lebanon Roads this year
  - Hebron roads seems to be using much more salt than previous years.
  - We need to talk with the towns on defining the Amston Lake water shed as a "low salt area"
  - Frank took the action to work with Amston Roads Committee and have a discussion with the towns, Action 159
  - Also discussed the Towns yearly cleaning of the catch basins around the lake area may not be adequate, Al Fichtel took an action to investigate and acquire pricing for additional catch basin cleaning by a contractor, Action 160
- Dam
  - o Inspections
    - Evacuation plan
      - Frank reported he sent emails to DEEP and the Author of the evacuation plan to help decide whether to revise the plan or make an amendment.
  - o Lake level
    - Excessive rain still fighting against trying to lower lake level, it was agreed to keep the weir boards at the lake lowering level until the mid-March time frame.
    - Jeff asked what the next steps are for the lake lowering as a result of the documentation the committee has reviewed and summarized. It was noted the past Limnologist, Northeast Aquatic Research has noted that they at times agree with lake lowering and disagree with lake lowering other times. Based on the

information we have reviewed there are no plans to change the lake lowering plan during the winter months

## 4. Water Testing Program

- Deepwater Testing
  - Both Kathy Feldman and Les Parlin noted they can help collecting samples.
- Storm Water Testing
  - Currently Jeff Arpin, Al Fichtel, Dave Bareiss will collect and Joyce Clark (when available) with Les as a backup as needed for sample collectors
  - Al Fichtel noted he may have others that can help and will check and report back. Action 161

#### • Main and Lollipop Beach Testing

- Joyce closed her action on Beach testing, currently no Town facility will test Lollipop area
- Jeff received *E. Coli* test costs from Phoenix Labs and currently has in the draft budget
- Les and Jeff determined that testing of all beaches occurred from 2004 until 2010 and it was possibly dropped due to an attempt to reduce the budget by the Towns
- Frank discussed possible liabilities of testing
- A discussion why the town of Lebanon does not take responsibility as Hebron has because even if we are a private lake there are Lebanon tax payers/residence at this lake.
- Frank will contact the town of Lebanon to see why they are not testing for the Lebanon residents. Action 162
- o Joyce will check to see if Columbia Labs will come and test lollipop beach, Action 163

#### • Limnologist Updates

- Jeff has been in communication with AER responding to comments to support their proposal, Jeff thinks we should receive AER offer soon.
- o Amston Lake 2020 Water Quality Monitoring report issued and will be put on the website
  - A glossary was discussed because some of the wording may be too scientific for the general public. There was nobody willing to take on the development of the glossary. It was noted that during the AER visit if the public wanted a better understanding they could ask questions. It was noted that it is very difficult to write a technical report that everybody would fully understand and in today's technology terms could easily be Googled if someone did not understand a particular word. It was also mentioned that in the past NEAR reports were more readable but contained much less information.
